Change of ownership at Tilbury

The Tilbury Green Power plant was acquired by a partnership of Greenvolt and Equitix in July 2021. Greenvolt owns 51% and Equitix owns 49% of the facility and the investment was founded on a long-term hold of a successful operating facility.

Tilbury Green Power is a fully operational 41.6 MW waste wood biomass plant, which was constructed between 2015 and 2019. It is one of the few facilities in the UK that is capable of processing low grade waste wood, sourced from demolition sites and household waste recycling facilities, recovering energy in the form of electricity. The plant diverts around 275,000 tonnes of waste wood which would otherwise go to landfill each year and in the process produces enough reliable, baseload electricity to power 97,000 homes. The plant helps to prevent over 300,000 tonnes of fossil-based CO₂ emissions from entering the atmosphere each year.

Tilbury Green Power is a complete and operational facility and if you see plans or construction coming forward at the site next door, that is the Thameside Energy Recovery Facility (TERF) which is being developed separately.

The map shows how the two sites will neighbour each other, with TGP being the existing site closest to the river and TERF sitting across the orange line. Planning consent for a 350,000 tonne Energy from Waste (EfW) facility was achieved by the previous owners ESB.
